1. Message from the Section President

Greetings! Since our last newsletter a year ago, the SPP has undergone significant reorganization and planning, while continuing to provide its suite of ongoing scholarly and teaching activities for its members.

Our routine activities include bestowing our six academic awards and holding our annual State Politics and Policy Conferences (SPPC). The 2019 conference was hosted by the University of Maryland, College Park. This three-day event was very well attended by over 120 scholars. Our other major ongoing activity is the publication of *State Politics and Policy Quarterly* (SPPQ). This year, SPPQ had a tremendous Impact Factor Score of 1.675 for 2018 (the most recent score), which placed the journal at 70th out of 176 political science journals—congratulations to all of us for making this happen! In particular, congratulations and thanks to Kris Kanthak and Chris Bonneau as they complete their sixth year as editors. Kris and Chris have done a tremendous job of not only making the train run on time but also in reaching out with new and exciting initiatives. Next year (2020), SPPQ will publish its 20th volume, demonstrating its importance and staying power in the discipline.

Over the past year, the section undertook two significant searches in relation to SPPQ. First, we searched successfully for a new editorial team for the journal. In June 2020, the team of Jonathan Winburn (Mississippi), Tracy Osborn (Iowa), and Conor Dowling (Mississippi) will begin taking new manuscripts for SPPQ, for a four-year term.

In the 2018-19 academic year, the section set up two ad hoc committees to study issues that the Council deemed of critical importance to the section: membership decline and inclusion and diversity. These committees filed impressive reports, which were presented at the 2019 business meeting. As a result of ensuing discussions, the section voted to establish the Inclusion and Diversity Committee as a permanent institution of the section. I have now appointed that committee and charged them with implementing the recommendations of the earlier ad hoc committee and with monitoring and improving the section's inclusivity and diversity going forward.

Finally, the section has made significant strides in fundraising, and we have ambitious plans going forward. About 10 years ago, the section initiated fundraising to endow its annual best dissertation prize, which it did at the initial level of \$25,000. About 18 months ago, in honor of our esteemed colleague and former SPPQ editor, Tom Carsey (University of North Carolina, Chapel Hill), who succumbed to ALS in 2018, the section undertook a fundraising campaign to endow a set of annual travel grants for graduate students for the SPPCs. The \$75,000 endowment goal was met in December 2018, allowing us to award the first "Carsey Scholars" travels grants to 10 graduate students attending the 2019 SPPC at UMD.

In addition to the great progress we have made in the past year, we now will consider future fundraising opportunities and where such a campaign might most help the section. I look forward to continuing to work with all section members in the coming year.

- Length: 500-1000 words
- Framing, language, and tone must be non-partisan
- Emphasis on political science contributions to civic engagement whenever possible
- Accessible and jargon-free writing (we want college students to be able to read easily and understand)
- Include photos if appropriate (of campus activities, etc)
- Include short bio and photo of author
