# **Proposed Editorial Team**

In reviewing the discipline and related journals, there are several successful models of editorship. We are proposing a two-person co-editorship model, where responsibility is split between the editors and they will maintain primary responsibility for particular subfields. While the current editorial team has operated very successfully with three people (editor-in-chief and two associate editors), prior editorships were successful with two-person teams, and similarly situated journals employ this model effectively. Our vision is to pair the co-editorship model with an active Editorial Board. Based on the volume of submissions – and conversations with prior editors, we believe that this will be a successful model for *Politics & Religion*.

# Co-Editor: Andrew Lewis (American Politics & Political Theory)

Dr. Andrew Lewis is an Associate Professor of Political Science at the University of Cincinnati. He holds a Ph.D. from American University (2011), and he is formerly a Public Fellow at the Public Religion Research Institute (2019-2021) and a Postdoctoral Research Fellow at the James Madison Program at Princeton University (2011-2012). Dr. Lewis's work integrates the study of religion with institutional politics and political behavior. He specializes in the politics of religion and law in the U.S., with a frequent focus on the politics of rights. Dr. Lewis is the author of *The Rights Turn in Conservative Christian Politics: How Abortion Transformed the Culture Wars* (Cambridge, 2017), which was the winner of the Religion and Politics Section's Hubert Morken Best Book Award. He is currently writing a book manuscript on the polarization of religious freedom in the U.S. Dr. Lewis is also the author of numerous peer-reviewed journal articles and chapters, including one that was recently awarded an Honorable Mention for the Ted Jelen Award for the best article published in the journal *Politics & Religion*. He has also written for popular outlets, including the *New York Times*, *Atlantic*, *Washington Post*, *USA Today*, and *FiveThirtyEight*.

In addition to his scholarship, Dr. Lewis has some editorial experience. From 2015 to 2018, he served as the Book Review Editor for *Politics & Religion*, and in 2019 he served as Guest Editor for a special issue of *The Forum* on "The Politics of Morality in the U.S."

Dr. Lewis has also been an active member of APSA and the Religion and Politics Section. In 2020, Dr. Lewis and Dr. Sultan Tepe served as Co-Program Chairs for the Religion and Politics Section of the American Political Science Association's Conference. In 2019, he served on the Religion and Politics section's book award committee. Dr. Lewis is also a frequent reviewer for prominent journals and university presses.

# Co-Editor: Sultan Tepe (Comparative Politics & International Relations)

Dr. Sultan Tepe is an Associate Professor of Political Science at the University of Illinois-Chicago. She holds a Ph.D. from the University of Texas-Austin (2002). She is the author of *Beyond Sacred and Secular* and is currently completing her forthcoming book, *Building Faith*, on the impact of local and transnational politics on religious communities and emergent theologies of Islam in the U.S. Dr. Tepe's *Beyond Sacred and Secular* offered one of the first cross-religious analyses of religious movements and parties in the Middle East, and it was

recognized by Choice's best national title award. In addition to her research, Dr. Tepe's commitment to curriculum development and advising of students have been recognized by several undergraduate teaching and graduate mentoring excellence awards. Her research projects have been supported by several grants from institutions such as the Humanities Institute, Northwestern University and research appointments such as the one granted by Stanford University's Freeman Spogli Institute for International Studies.

In addition to her regular participation in APSA annual meetings, Dr. Tepe has contributed to the APSA pre-conference short courses and co-organized a short course on the Middle East. She has served on numerous award committees and received the APSA Religion and Politics section Distinguished Reviewer and Weber Best Paper awards. She was the Religious and Politics division co-chair of the 2020 APSA conference with Dr. Lewis and co-organizer of several international conferences such as the Refugee Crisis (2020-2019). She is also a contributor to several professional associations including the European Consortium for Political Research (ECPR), the Middle East Studies Association, and International Studies Association. The interdisciplinary foci and scope of Dr. Tepe's research have enabled her to work with a broad range of scholars who focus on Democratic Theory, American Political History, Black Studies, Comparative Populism, and International Conflict, collaborate with scholars from different countries including Italy, New Zealand, Germany, and India, and contribute to various national and international programs such as the International Metropolis Conference and the ECPR Religion and Politics summer schools.

Dr. Tepe has contributed to several journals in various capacities, from editing a special issue to reviewing submissions. She regularly reviews grants, book and article manuscripts for American and International foundations, journals and university presses.

# Additional Staff

We expect to recruit two students as Editorial Assistants, one from the University of Cincinnati for Dr. Lewis and one from the University of Illinois-Chicago for Dr. Tepe. The competitive funding at the University of Cincinnati is offered by the Graduate School at the University to fund a graduate student to assist the journal, and the funding line at the University of Illinois-Chicago's is offered by the College of Liberal Arts and Sciences and the Graduate College. The Editorial Assistants will help with processing manuscript submissions and acceptances, locating potential reviewers, external communication, and promoting the journal on social media.

In addition, we also plan to hire an Undergraduate Student Assistant(s) from the University of Cincinnati for five hours per week. The Undergraduate Student Assistant(s) will primarily help manage social media and the website.

#### **Our Vision**

The prior editors of *Politics & Religion* have done an outstanding job of making the journal the standard-bearer for religion and politics scholarship with both a domestic and international focus. The journal's high ranking in the most recent Journal Citation Indicator, as well as its growing Impact Factor, is the latest proof of these excellent efforts. In light of the excellent record and

momentum the journal's current and previous editors have established, our priority will be building upon this outstanding work, cementing the role of the journal as the go-to publication for research at the intersection of religion and public life. We will continue the tradition of displaying high-quality research that represents the breadth of the subfield, in substance, methodology, and authorship, and inspires future research.

Given that the previous editorial teams have done an excellent job with the journal, we see no need to make major changes to approach or process but plan to build on their efforts to heighten the visibility of the publication while addressing the needs of different readers. Therefore, we will pursue some new initiatives to continue to accelerate the journal's success and to serve the section. Our potential initiatives include:

- Encourage Short Article Submissions and State of the Field Reviews: The journal occasionally publishes research notes which often highlight descriptive findings, improve methodological approaches, extend prior research, and introduce new research areas. Expanding on this aspect of the journal we plan to build a regular section for short, peerreviewed articles (< 10 pages). We will encourage short submissions that have important insights and impact the field without being comprehensive research papers. As with existing research notes, these may be descriptive findings, methodological improvements, replications, or other types of articles where the substantive focus is important to the field, but narrower than a full article. These will continue to be peer-reviewed, but we hope to expedite publication process on these short articles. We will also encourage occasional state of the field reviews, which will offer a bird's-eye view of some of the emerging debates; we will invite members to submit critical reviews of arguments in new research areas (e.g., populism and religion). Such reviews will draw attention to new research areas, assess existing studies, and identify areas that require further research.
- Bridge the Journal and APSA conferences: We hope to improve the relationship between the Section conference offerings and the journal, with the goal of improving journal submissions and exposure. To do this, we seek to coordinate with the section's division chairs to think about future journal publication at the conference stage. As part of this we will encourage section members to offer mini-conference or panel proposals to better develop their articles for submission to the journal. APSA's mini-conferences or theme panels can allow the section members to have more extensive discussions on pressing issues. We will increase coordination with the division chairs and encourage section members to utilize mini-conferences or panel proposals to improve the quality of their submissions to the journal. While such mini-conference participations or panel presentations will not guarantee the outcome, such efforts will better interface the research-based workshops and publications aspect of APSA.
- Engage in Publication Mentoring: The Journal will hold workshops (either at APSA or virtually) to help advanced graduate students and junior scholars to understand the review process better and improve their working papers, with the goal of eventually publishing their research in the journal. We encourage the section to consider making resources available for these efforts.

- Emphasize Thematic Issues or Sections: Given the pivotal role of religion in domestic and global issues, the journal is uniquely positioned to contribute to some ongoing discussions not only through publishing individual articles but also by creating dialogue around distinct themes. Instead of dedicating the entire issue to a single theme, we plan to have special theme sections on topics such as race relations within faith communities, conflict promotion/prevention and religious activism, and gender-based marginalization and theologies. For each theme, we will have a call for submission and all submissions will be subject to regular peer review.
- Improve Social Media Presence and Impact: In order to increase awareness of the Journal's contributions to pressing questions (e.g., the role of religion in anti-systemic protests) and recognition of the main findings of the published articles, we are committed to increasing the journal's presence on social media platforms while making the announcements approachable to broader audiences. We have received a commitment from the University of Cincinnati to fund an undergraduate student to help us with this.
- Provide Benefits for Reviewers and Editorial Board Members: Securing reviewers and timely receipt of reviews is an issue for Politics & Religion, along with other social science journals. While we cannot relieve all the pressures on reviewers, we hope to take some steps to provide certain benefits. We will send frequent, personalized notes to reviewers, and we will work with the Executive Committee and Cambridge to seek discounts for reviewers. We also hope to build a collegial atmosphere among the Editorial Board, including an annual get-together at APSA. In addition, we will continue to work with the Section to honor outstanding reviewers each year.

In addition to these initiatives that expand on the journal's existing work, we have goals similar to those of the prior editors. These include:

- Maintaining the journal's reputation as the leading outlet for high quality religion and politics scholarship
- Ensuring efficient processing times
- Sharing blind reviews with all reviewers
- Ensuring intellectual integrity
- Cultivating a diverse editorial board (more on this below)
- Engaging in outreach to international scholars
- Ensuring that the journal reflects the plurality of research interests and methods in the field

#### **Division of Labor**

As with prior teams, we propose to build an editorial model that can oversee the breadth of religion and politics scholarship, while also cultivating high quality research. Our scholarship transcends traditional sub-field boundaries, but it is also complementary, with very little overlap.

Dr. Lewis will be the lead editor for American Politics, as his expertise covers religion and American politics broadly, often intersecting behavior, institutions, and public law. Dr. Lewis

will also serve as the point person for political theory, though he will lean heavily on the Editorial Board for political theory submissions. Submission patterns indicate that political theory comprises a small portion of manuscripts overall, and we anticipate that having an editor who can work closely with the Editorial Board on political theory submissions will be effective. Finally, Dr. Lewis will be the lead for communicating with Cambridge University Press and the section.

Dr. Tepe will be the lead editor for Comparative Politics and International Relations, as her expertise covers numerous topics from religious parties to dissident religious movements. Dr. Tepe has been an active contributor to several debates from the moderation of religious parties and the subversive use of theologies in shaping domestic and international politics as well as the marginalization of religious women's movements. She has been contributing to several research projects from the role of religion in the ruling right-wing party's discursive appeal in Indonesia and India, the role of transnational groups and the Church in the strategies of LGBTQ+ communities in Poland, and the right-wing parties in Germany to the religious movements in Brazil. The regional scope of her comparative and international scholarship along with the expertise of the board will enable the journal to expand and assess submissions from different research communities.

The journal's increased ranking and reputation illustrate that it has established itself as an important platform to accommodate the methodological plurality of the field. We believe such a plurality is more important than ever given the intricate nature of issues posed by religion. Both editors, while empirical scholars, employ multiple methodologies in their research, and will continue the journal's emphasis on methodological pluralism. Dr. Lewis's research often mixes quantitative, qualitative, and historical research, and Dr. Tepe's research is multi-method and draws on both qualitative and quantitative research methods. Both Dr. Tepe and Dr. Lewis's training and research emphasize interdisciplinary approaches to scholarship. Dr. Lewis has designed and fielded multiple national surveys and survey experiments, while also conducting interviews and archival research. Dr. Tepe has taught both quantitative and qualitative research methods courses, designed several nationally representative surveys, and conducted extensive ethnography in the U.S., Israel, and Turkey and completed a pilot research in Germany and France.

We are also aware of the areas where we are not experts and value the benefits of deliberation in the areas we research. Therefore, we plan to consult with the Editorial Board to help us fill gaps in our expertise. As discussed previously, we will be looking for an especially strong cohort of political theory experts for the Editorial Board, as well as individuals who will help provide depth for frequent submission areas.

We are committed to having an Editorial Board that is actively involved in the journal and that represents the section both substantively and descriptively. We will solicit a diverse and inclusive Editorial Board, and one that will continue to raise the international profile of the journal. To do so, we will consult with the Executive Committee and former journal editors to build an Editorial Board that is descriptively and substantively diverse, representing the best of our broad subfield. We will work diligently to having a Board that reflects the variety of research topics and methods, as well as the plurality of locations, races, genders, and institutions of higher education, represented by the section's members and the journal's audience.

#### **Review Process**

We will work closely as a team to maintain the high-quality review process the journal has established over the years. Each co-editor will supervise submitted manuscripts that fall within their areas of expertise and defined responsibility. Final reviews for each manuscript will be vetted by both co-editors, but the ultimate decision for each manuscript will rest with the co-editor in charge based on subfield responsibility. As with the prior editorial team, the co-editors will collaborate routinely to make sure there is adequate coverage and a consistent standard across manuscripts. We will also work closely with subfield specialists on the Editorial Board, especially when the editors lack expertise or are divided on an outcome. Strong collaboration across subfields is a hallmark of the Religion and Politics section and *Politics & Religion*, and we aim to continue that tradition.

As a team, we will be responsible for the overall supervision of the processing of manuscripts and ensure that the production of the issues of the journal is completed in a timely fashion. We will also supervise graduate Editorial Assistant(s), who will help in the processing and production of manuscripts. We will also supervise the student, who will help enhance the promotion of articles on social media and coordinate with Cambridge to maximize the journal's website.

Our proposed plan to manage reviews will be similar to the prior editorial team. It is, as follows:

- The Editorial Assistant will process the incoming manuscripts, be given a detailed set of criteria to determine whether the manuscript should be directed to Dr. Lewis or Dr. Tepe, and (hopefully) contribute to the identification of possible reviewers.
- The responsible co-editor will then determine if the piece is reviewable by the journal, and if not, inform the authors immediately that the piece will not be reviewed. The goal will be to notify authors of desk-rejections within 21 days.
- If the manuscript is selected for a full review, the responsible editor will contact potential referees and supervise the review of the manuscript, with the goal of having the manuscript under review within 30 days of first receipt of the piece.
- After reviewing the recommendations made by at least three referees (normally), the coeditor assigned to the manuscript will then decide whether to (i) accept the manuscript for publication outright (ii) offer the author(s) some opportunity to revise and resubmit the piece (iii) or reject it. The goal will be for the average review time from submission to first decisions to be under 90 days, keeping the high standards set by the current editorial team.
- The co-editors will conference before making final decisions.
- Throughout the review process the editor in charge of the manuscript, when further discussion is needed, will request the feedback of the subfield cohort on the Editorial Board. This includes whether to review, providing peer reviews, assessing peer reviews, and weighing in on final decisions.

# **Proposed Contributions from the Universities**

# University of Cincinnati

The University of Cincinnati is a tier-one urban, public research institution with the capacity and interest to support a major academic journal. Importantly, the Department of Political Science has a broad, and accomplished group of faculty who conduct religion and politics research, including three of the past four winners of the Hubert Morken Award. The University and the Department of Political Science welcome the opportunity to co-host the editorship of *Politics & Religion*.

As the attached letter indicates, the Department of Political Science at the University of Cincinnati has committed to supporting the journal. In particular, the Department will help secure an Editorial Assistant for the journal. There will be two avenues for securing the Assistant. The University offers an Editorial Assistance Award to support faculty who edit academic journals. The award would be for a Graduate Assistant scholarship and an academic-year stipend of \$18,000 to fund a PhD student in the Political Science Department. The award is not guaranteed, but is likely, and we would apply in November 2021. If received, the Department of Political Science would provide office space and computing/printing resources for the graduate assistant. In the case that the application for the Editorial Assistance Award is not successful, the Department of Political Science has committed to providing editorial support through the Department's existing allotment of graduate assistants, to make sure that there is a successful transition for the journal.

In addition, the Department of Political Science has committed to provide the funds to hire an Undergraduate Student Assistant for 5 hours per week to help manage social media, and it has agreed to provide two course releases for Dr. Lewis over the five-year term. The Political Science Department Head and the College Dean both support the application. An attached letter from the Department Head provides more details about the University of Cincinnati's Commitment.

Finally, the Department of Political Science and the University's Taft Research Center also have travel funding available for the co-editor to attend 2-3 social science conferences each year to present research, promote the journal, and engage in mentoring activities (\$3000-4000/year).

# University of Illinois-Chicago

The University of Illinois at Chicago is a tier-one public research institution located in a global city known for the plurality of its religious landscape. It is a part of the University of Illinois system and a local consortium with the University of Chicago and Northwestern University that allows these institutions to pool their resources. UIC is one of sixteen minority-serving public research institutions in the nation. With its minority serving, tier one research status, and internationally focused mission, the University welcomes the opportunity to co-host the editorship of the *Politics & Religion*. Hosting the editorship of the Journal aligns with the

University's mission to advance socially relevant research and offer insights to globally pressing issues. UIC prides itself in developing a rigorous Religious Studies Program. In addition to the Political Science Department the university has many scholars in other departments such as the Departments of Psychology, History or Urban Planning whose research lie at the intersection of religion and politics. UIC has a well-established record of managing the editorships of several journals such as *Gender and Society or* the bilingual *Dialogue and Discourse*. Various services for such journals are offered through the University's Office of Social Science Research (OSSR). OSSR will be able to support the journal through its different infrastructures, from facilitating recruitment of a student from a large pool of qualified applicants to support the journal's activities to arranging the platforms to promote the journal's publications. The University of Illinois will be able to assign a graduate assistant to support the journal. The University's commitment to hiring such a student includes a monthly stipend in addition to the tuition and health benefits at Chicago, which amounts to \$34,000 per year for an international student and \$15,000 for a U.S. student. In addition, the University offers funds to cover registration and travel expenses to encourage the recruited students to attend APSA conferences.

As a leading minority-serving institution, the student's involvement and employment such as that to be offered by *Politics & Religion* are further supported by numerous federal and private funds dedicated to enriching the learning and professional experiences of students. Among others, the journal will be given the opportunity to benefit from a new program to recruit a paid student intern for the summer. The University's multiple programs and centers, such as the Religious Studies, the Institute of Humanities, and the Great Cities, regularly organize lectures and workshops that reach out to a broad national and international audience and will be pleased to offer the necessary platforms to promote *Politics & Religion* 's publications and activities.

Dear APSA Religion & Politics Section,

I write to strongly support Dr. Andrew (Andy) Lewis as co-editor of the journal *Politics & Religion*. I currently serve as Department Head in the Political Science Department at the University of Cincinnati. I have worked closely with Andy for the past 9 years, and I fully support his application to be a co-editor of the journal. Andy's academic record and outstanding work as a colleague at the University of Cincinnati give me nothing but confidence.

In my administrative capacity, I will begin by saying that the Department of Political Science and the College of Arts and Sciences would be thrilled if Andy were chosen to be co-editor, and we will do our best to support him in our resource constrained environment. In particular, as Department Head I commit to supporting the following:

- 1. Securing a Graduate Assistant from the University of Cincinnati to help manage journal submissions. The best path to fund a Graduate Assistant is through the Graduate School's "Editorial Assistance Award." This is a competitive award, but my assessment is that Andy has a very strong case. I will support him fully with that application which is due this coming November. If Andy is unsuccessful in securing this award, I will work with him through the Department's already allocated Graduate Assistants to provide support for the journal of approximately 10 hours per week during the semester (half of a Graduate Assistant assignment). I am also hopeful that we will have some summer funding available for the graduate student assigned to the journal.
- 2. Securing an Undergraduate Assistant from the University of Cincinnati to help manage social media. For each year, the Department of Political Science will commit to funding an undergraduate student for approximately 5 hours per week to promote the journal on social media. We will use local resources to pay an undergraduate for this work.
- 3. **Managing Dr. Lewis's Workload**. I recognize that co-editing an APSA journal is a major time commitment that also speaks well of the research profile of our Department, College, and University. As Department Head, our contract gives me the ability to adjust workload assignments, and I will commit to providing an adjustment for Andy for this service to the discipline. Over the 5-year period, I will give him a two-course reduction for his service as journal editor. This will be taken during a mutually agreed upon semester between Fall 2022-Fall 2026.
